

HOW TO APPLY FOR CANADA-UKRAINE AUTHORIZATION FOR EMERGENCY TRAVEL (CUAET)

Below is a Summary of Procedures on how to Apply for the Canada-Ukraine Authorization for Emergency Travel program.

Please note that this document is a summary of information that has been made available to the general public by the Government of Canada. The information and guidance provided in this document does not constitute legal advice and should not be relied on as such. If legal advice is required, please contact us about your specific matter.

NOTE: On March 18, 2022, the Government of Canada announced special measures to assist Ukrainian citizens and family members of Ukrainian citizens to come into Canada, including a fast-track program for temporary residence known as Canada-Ukraine Authorization for Emergency Travel aka ‘CUAET’.

In order to travel to Canada, a citizen of Ukraine, or a family member of a Ukrainian citizen needs to either (1) have a valid Visa, or (2) apply for a Visa on the IRCC Portal (<https://portal-portail.apps.cic.gc.ca/signin?lang=en>).

The CUAET gives you a visitor visa to come to Canada temporarily, until it is safe to return to Ukraine. The visitor visa

- **is fee-exempt (NO IRCC FEES)**
- **is valid for 10 years or until your passport expires**
- **allows you to travel in and out of Canada, as long as your visa is valid**
- **will be processed on a priority basis**
- **gives you the option to apply for a fee-exempt work permit at the same time**

When you arrive at the border in Canada, you’ll be given status as either a

- **visitor**
- **worker, if you applied for the open work permit**
- **student, if you’re under 18 and want to study in Canada**

You can stay in Canada for up to 3 years at a time or until your passport expires. When your status in Canada is about to expire, you need to apply to extend your stay.

Please note that applying for CUAET not guarantee that the application will be approved. This is because an Immigration Officer will make a final decision based on the application.

1) SUMMARY

This guide provides instructions on the steps required to apply for CUAET.

Step One:

- Apply for CUAET online via the IRCC Portal and submit your application
<https://www.canada.ca/en/immigration-refugees-citizenship/services/immigrate-canada/ukraine-measures/portal-application-ukraine-cuaet.html>

Step Two:

- The Government of Canada will request the Applicant to provide biometrics (fingerprint and photo) at a Visa Application Centre if the Applicant does not already have valid biometrics on file. Biometrics are valid for 10 years.
- Currently, the Visa Application Centres in Ukraine are closed. Given this, in order to finalize the application, the Applicant will either need to (1) submit a request for exemption of the biometric requirement required to be submitted in the CUAET application by uploading a request letter (attached at Appendix “A” hereto is a form of this request letter that can be used), or (2) travel to a Visa Application Centre from outside of Ukraine to complete the biometrics requirement. IRCC has confirmed that they will be deploying temporary stations accessible to applicants to complete this requirements.

Step Three:

- Lastly, before the CUAET application is approved, the Applicant will need to mail their passport to a Visa Application Centre in Ukraine or outside of Ukraine. The Applicant would need to travel to that location in order to pick up the passport with the Visitor Visa. We would recommend that all applicants phone/email the Visa Application Centre prior to travelling to confirm hours of operation and their ability to assist with this.

NOTE: If the Applicant is unable to travel to another country to submit biometrics or pick up their original passport with a visa stamp, it is still worth submitting an application as the Government of Canada may decide to make exemptions with respect to these requirements as the situation evolves. As of March 30, 2022, no such exemptions have been confirmed; however, this may be subject to change.

2) OTHER TRAVEL CONSIDERATIONS RELATED TO COVID-19

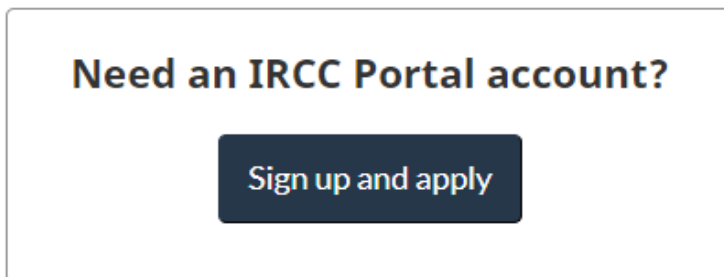
A citizen of Ukraine or a family member of a Ukrainian citizen to be allowed to board an airplane to travel to Canada, they are no longer required to be fully vaccinated for COVID-19. You must meet all other public health requirements, such as quarantine and pre-and post-arrival testing.

3) CUAET APPLICATION

Below are the steps to apply for the CUAET on the IRCC Portal. You will need to have access to a computer with internet access to complete the next steps.

1. **Website:** The website to apply for CUAET is as follows:

You will need to sign up for an IRCC Portal account. Please remember the email address and password you use to create the IRCC Portal account because you will need this information to log into the IRCC Portal.



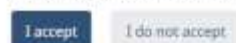
2. **Terms and Conditions:** After you have signed into the IRCC Portal, you will need to accept the terms and conditions by clicking “**I accept**”.

Terms and conditions

By accessing your account, you are agreeing to abide by the following Terms and Conditions of Use:

- You agree to keep your identification number(s) confidential and to not share it (them) with anyone. If you suspect that others have obtained your identification number(s), contact us immediately by clicking the Contact us link (at the bottom of any IRCC web page) and complete a case-specific enquiry.
- You certify that any information provided by you is true, accurate and complete.
- You understand and accept that as a security measure for administrative reasons, we can revoke your access if you fail to abide by the Terms and Conditions of Use.
- You understand and accept that we are not responsible for any losses or damages incurred by anyone because of:
 1. The use of the information available in your account
 2. Any restrictions, delay, malfunction or unavailability of your account
- You understand and accept that by using your account and applying online, we can communicate with you (or your representative, if applicable) via email.
- To continue, choose "I accept" to indicate your acceptance of these Terms and Conditions. If you do not agree with these Terms and Conditions, choose "I do not accept". Note, you will not be able to access your account unless you accept the Terms and Conditions.

If you use another type of browser software you should check with your software supplier to make sure that your browser has 128-bit secure socket layer encryption capability. Note: We are not responsible for any difficulties in downloading and installing software. Software suppliers are responsible for providing technical support. 3. **Select the type of application you want to apply for:** You will select “**Apply for a visitor visa, transit visa or a study permit.**” You will have up to 60 days to complete and to submit the Visitor Visa application online.

- Proof of relationship with your immediate family member (only for an immediate family member applying for the CUAET)

Documents that show your relationship to that family member

Examples of documents include

- a marriage certificate or proof of common-law status (documents showing a shared address)
- a birth certificate
- other documents that show an immediate family connection, for example
 - correspondence from us showing a spousal sponsorship application in progress
 - documents that show a shared home address

Note: The documents above are examples only. An officer may request or accept other documents, as needed.

You may need other documents depending on how you answer the questions in the application.

Supporting documents:

1. Travel document (MANDATORY)

A clear colour copy of your valid passport or travel document that you'll use to travel to Canada.

If you have a passport, you must provide a copy of

- the page that shows your birth date and country of origin, and
- any pages with stamps, visas or markings

If you have a travel document, it must be issued by a government and include your

- name
- date of birth
- document number
- citizenship or residency status
- photo, and
- expiry date (if applicable)

Optional Documents

1. Proof of funds:

How much money do you have for your stay in Canada? (In Canadian dollars). Even if you do not have savings or funds readily available to you, it is still worth including a letter stating how you will pay for

your air tickets to arrive in Canada and the plan you have for your stay in Canada.

If you have family or friends in Canada, then you may include a letter from this person including the following information. The letter must include the amount of money this person will be providing, plus proof that this person has sufficient funds. This can be one or more of the following:

- proof of a Canadian bank account in the name of the person providing you with money if funds have been transferred to Canada
- proof of a student/education loan from a financial institution
- bank statements for the past 4 months
- a bank draft in convertible currency
- proof of payment of tuition and accommodation fees
- a letter from the person or institution providing you with money
- proof of a student's education loan from a financial institution
- a letter from the person or institution providing you with money
- proof of funding paid from within Canada, if you have a scholarship or are in a Canadian-funded educational program

The person must also provide evidence of their relationship with you. Depending on the type of relationship, this could mean a copy of a marriage certificate, phone records, birth registration, family documents or photos.

2. Additional documents

Any additional documents or explanation that you think may assist the processing officer. Typical examples of additional documents may be your resume/CV, National ID (front and back), copy of an expired passport, ties to your home country – Ukraine (copies of deeds, asset ownership) etc. These are not mandatory, but rather optional documents that may assist an IRCC officer reviewing the application.

8. Consent and Privacy policy

Consent and declaration

Citizenship and Immigration Canada (CIC), or an organization at CIC's request, may want to contact you in the future to ask you about any services you received from CIC prior to the application process (such as participation in an information forum), during the application process (including the application process itself as well as orientation or accreditation services), and services received after arriving in Canada (including settlement, integration and citizenship). CIC will use this information, along with the information provided by other individuals, for research, performance measurement or evaluation purposes. CIC will not use this information to make any decisions about you personally.

Personal information provided on this form is collected and will be used, disclosed, and retained by Immigration, Refugees and Citizenship Canada (IRCC) under the authority of the Immigration and Refugee Protection Act (IRPA). The personal information provided will be used for the purpose of processing applications. The personal information provided may be disclosed to other federal government institutions and third parties including law enforcement bodies, provincial/territorial governments and/or foreign governments for the purpose of validating identity, eligibility and admissibility.

The personal information collected on an application, and other information collected in support of an application, may be used for computer analytics to support processing of applications and decision making, including your application. Personal information, including from computer analytics, may also be used for purposes including research, statistics, program and policy evaluation, internal audit, compliance, risk management, strategy development and reporting.

Where biometrics are provided in support of an application, the fingerprints collected will be stored and shared with the RCMP. The fingerprint record may also be disclosed to law enforcement agencies in Canada in accordance with subsection 13.11(1) of the Immigration and Refugee Protection Regulations. The information may be used to establish or verify the identity of a person in order to prevent, investigate, or prosecute an offence under any law of Canada or a Province. This information may also be used to establish or verify the identity of an individual whose identity cannot reasonably be otherwise established or verified because of physical or mental condition. Canada may also share immigration information related to biometric records with foreign governments with whom Canada has an agreement or arrangement.

Failure to complete the form in full may result in a delay or the application not being processed. The Privacy Act gives individuals the right of access to, protection, and correction of their personal information. Further details are available in Info Source. If you are not satisfied with the manner in which IRCC handles your personal information, you may exercise your right to file a complaint to the Office of the Privacy Commissioner of Canada. The collection, use, disclosure and retention of your personal information is further described in IRCC's personal information bank - IRCC PPU 068.

9. Submit the Application.

Remember that the IRCC has waived application and biometric fees.

10) WHAT TO DO AFTER YOU HAVE SUBMITTED YOUR APPLICATION

In order to request for urgent processing of your CUAET application, you need to submit an IRCC webform. Below are the instructions.

11) BIOMETRICS

On March 22, 2022, VFS Global website posted the following notice:

Due to the current situation in Ukraine, some of our Visa Application Centres (VACs) are experiencing higher volumes than usual. Immigration, Refugees, and Citizenship Canada (IRCC) has introduced temporary biometric collection sites, accessible via online appointment booking only, for Ukrainian nationals and their immediate family members* of any nationality arriving from overseas at the following locations:

Re: Visitor Visa Application – Request for Exemption from Biometric Requirement

I am applying for a Visitor Visa and I am currently located in Ukraine. There is currently a war between Russia and Ukraine. As such, the Visa Application Centres in Ukraine are all closed.

Below is a screenshot from the IRCC website dated March 30, 2022 that confirms the two Visa Application Centres in Ukraine are closed. Further, the Visa Application Centre in Poland is not open to the public. Accordingly, it is not possible to complete the biometric requirement for the Visitor Visa application

Given this, I respectfully request for exemption from the biometric requirement and to complete the biometric requirement upon my arrival in Canada.
